Respected Sir/ Madam,

With reference to your circular No. 06/2020 and previous Letter No.CBSE/Aff./Govt. Wing/400040/2019/ 19488 dated 19/07/2019 it is to inform you that we have paid Rs. 9000/- (Nine Thousand only) towards Annual affiliation fee vide DD No.638286 dated: --.02.2019 for the period 01.04.2019 to 31.03.2022, also we sent a difference of Rs. 6000/- due to revision of Annual Affiliation Fee of @Rs- 5000/- per annum but the DD was not accepted and was resent to us as no offline fee is being accepted.

But we are unable to pay fee online as the website is showing fees paid up to 31.03.2013 only and it is showing Rs. 33000 (Thirty-three thousand only) pending to pay where as we have to pay Rs.6000 (Six thousand only) towards pending Annual affiliation fee upto 31.03.2022. Furthermore, this Vidyalaya has paid Rs. 9000 already through DD and is received by you as per your letter no. CBSE/AFF./Govt./400040/ 2010 /18522 dated 25/03/2019 and remaining fee i-e. Rs. 6000 is to be paid. So, it is not possible to pay online through CBSE affiliation fee portal. This Vidyalaya has requested the same vide letter F. 120346/01/2019-20/केविसमाना/ Dated 17/07/2020 and through e-mail to cbseaff.govt@gmail.com on 25 June 2020, 14 July 2020, 30 Sept 2020, 05 Dec 2020, 08 Dec 2020 & 23.01.2021 and to hqit10@cbsseshiksha.in on 20.09.2020, 05.10.2020 and 07.12.2020 but the issue can not be resolved.

Hence, I request you to update the fee paid so far on the website and provide the link for payment of remaining fees Rs- 6000 (Six Thousand Rupees Only) or allow us to pay the due fee through Demand draft. Please acknowledge.
